## **Board Minutes** January 3, 2017

The Adams County Board of Supervisors met on Tuesday, January 3, 2017, at 9:00 am for the Organizational Meeting, with the following members present: Linda England, Leland Shipley, Doug Birt, Merlin Dixon, and Karl McCarty.
