RESOLUTION 2022-37 ADAMS COUNTY PRECINCT ELECTION OFFICIAL & SUPPORT STAFF COMPENSATION POLICY

WHEREAS, the Adams County Board of Supervisors does acknowledge the importance of Precinct Election Officials and Support Staff in the Election Process.

WHEREAS, the Adams County Board of Supervisors approve the following hourly rates for Precinct Election Officials & Support Staff effective October 24, 2022.

Position	Recommended Salary
Precinct Election Official	\$175/Day
Precinct Election Official – Chair or Co-Chair	\$200/ Day
Election Health Care Delivery Team	\$10/ Hour
Election TM Runner	\$10/ Hour
Election Absentee Board	\$10/ Hour
Election Audit Board	\$10/ Hour

WHEREAS, the Adams County Board of Supervisors approves a mileage rate for all election workers that travel more than 5 miles one-way for service in an election following the standard County mileage reimbursement rate.

THEREFORE, BE IT RESOLVED that the Adams County Board of Supervisors adopts the compensation recommendations for the previously listed workers, which will remain in effect until a new compensation policy is passed.

The regular Board of Supervisors meeting originally scheduled for November 14th will be moved to November 15th at 9:00 am to canvass the General Election of November 8.

Department Head reports were presented as follows: Secondary Roads – HMA project is underway again and we are seeing the quantities have been higher than expected. This has led to Secondary Roads taking over the shoulder project. Recorder – Stargell received her books back from the scanning project. Auditor – Bissell spoke to three Middle School classes on Friday over in Villisca about elections. Last day to mail out Absentee Ballots are Monday Oct 24th, but in-person Absentee Voting is still going on in the Auditor's office until Nov 7th. The office will be open Saturday Nov 5th from 9-5. IT – Testing the new texting feature this week and should be implemented by next week. Sheriff – City of Corning received a grant to put up cameras around Corning. They are up and operational. Conservation – All docks are out of the lake and restrooms are all shut down. The archery range should be operational by spring. A monetary donation was received by the Conservation department for a shelter house. They plan to build it at the new archery range. The Lake hosted the District Cross Country meet with 19 schools attending. There are a few improvements that will need to be made to the trail. The lake is getting security cameras out at the shop. Marti passed the physical test to go to the LEA in Jan. REAP committee meeting met and discussed projects.

Committee and Meeting reports were presented as follows: Shipley – Loss Control, Corning, October 19; Akin – ACEDC, Corning, October 20 and Southern Hills, Corning, Oct 21; and Maynes – Crossroads Finance, Via Zoom, Oct 18.
