## **Board Minutes January 9, 2023**

The Adams County Board of Supervisors met on Monday, January 9, 2023, at 9:00 AM with the following members present: Leland Shipley, Chris Standley, Tony Hardisty, Bobbi Maynes and Scott Akin. The meeting was called to order by Chairperson Shipley and the Pledge of Allegiance was recited. Akin moved, seconded by Maynes to approve the minutes of January 3<sup>rd</sup> meeting and to amend the agenda for today's meeting by adding the appointment of a replacement board member on the Conservation Board. All supervisors voted aye. Motion carried.

Shipley asked for public comments. The Adams Community Ambassadors are seeking legislative priorities for their annual "Day On The Hill" visit with the Iowa Legislature and the Governor. City of Corning Mayor Jan Leonard announced the City was granted a DOT 50/50 cost share bridge repair/replacement for the 4<sup>th</sup> St. bridge. The City will need an agreement for help with the engineering from the County.

Crossroads Director Brittany Palmer addressed the board on possible programming that Crossroads could help provide using the County Opioid Funds. They include prevention strategies with the school, jail, treatment, and other diversion programs.

Maynes moved, seconded by Hardisty to approve the Treasurer's Semi-Annual Report and Investment Report. All supervisors voted aye. Motion carried. Treasurer Schafer shared with the board the current interest rates that are available for funds.

Akin moved, seconded by Standley to approve using ARPA funds up to \$15,000 for the Recorder's Preservation Project. There are still approximately 185 books left to scan and some other assorted non-bound items of historical significance. With \$5000 from the Recorder's Records Management Fund, this should complete the project. All supervisors voted aye. Motion carried.

Standley moved, seconded by Hardisty to approve the Recorder's Quarterly Report. All supervisors voted aye. Motion carried.

Akin, moved, seconded by Standley to approve Rob Tucker to the Adams County Conservation board due to the resignation of Wayne Rychnovsky. All supervisors voted aye. Motion carried.

Maynes moved, seconded by Akin to approve the claims. All supervisors voted aye. Motion carried.
