The Adams County Board of Supervisors met on Tuesday, January 17, 2023, at 9:00 AM with the following members present: Leland Shipley, Chris Standley, Tony Hardisty, Bobbi Maynes and Scott Akin. The meeting was called to order by Chairperson Shipley and the Pledge of Allegiance was recited. Akin moved, seconded by Maynes to approve the minutes of January 9th and 13th meeting and to approve the agenda as presented. All supervisors voted aye. Motion carried.

Adams/Taylor County Public Health Director Crystal Drake gave an update to the board on the department. They have seen an uptick in requests for CPR/AED Training. Public Health was awarded the Maternal Health Grant so they will be able to offer more services in that area.

Budget presentations were presented by: Public Health, MATURA, and Southern Iowa Trolley. Budget Discussions were held as well.
