## **Board Minutes March 24, 2025**

The Adams County Board of Supervisors met on Monday, March 24, 2024, at 9:00 AM with the following members present: Tony Hardisty, Scott Akin, Leland Shipley, Bobbi Maynes, and Chris Standley. The meeting was called to order by Chairperson Hardisty at 9:00 AM. The Pledge of Allegiance was recited. Akin moved, seconded by Maynes to approve the agenda. All supervisors voted aye. Motion carried. Maynes moved, seconded by Shipley to approve the minutes of the March 17<sup>th</sup> meeting. All supervisors voted aye. Motion carried.

Akin moved, seconded by Standley to approve signing the contract and approve performance bond with Godberson for project LFM-LBCOL19—7X-02. All supervisors voted aye. Motion carried.

Secondary Roads Update – Conducting sample borings on Lincoln 3 & 4, Nodaway 9, and Prescott 10. Sent out notifications on road closings or restrictions. Crushing concrete this week for one-inch shoulder rock. The quarry ran out of crushed rock last week so started using Class A rock. Got the skid steer and twin screw that was sent out for repairs back. Sent both owned and rented skid steers out to clear trees. Will be demoing a CAT skid steer. Planning to finish trees this week because the rented John Deere skid steer goes back next Monday or Tuesday. Weather permitting the crew will be hauling rock during the month of April. Some items have sold on Purple Wave and the rest of the equipment will be sold April 1st.

Maynes moved, seconded by Standley to rescind the motion from March 17, 2025, for the 3% raises for FY25/26 Salaries. All supervisors voted aye. Motion carried.

Maynes moved to 3% for all hourly and salaried employees except for 0% for Attorney, and 4.5% for Sheriff. Motion died due to lack of second.

Maynes moved, seconded by Standley to approve 3% for all hourly and salaried employees except for 1% for Attorney, and 4.5% for Sheriff for FY25/26. All supervisors voted aye. Motion carried. Resolution 2025-13 was tabled until next week.

Chair called for a recess at 9:57. Came back from recess at 10:15 am.

Standley moved, seconded by Maynes to terminate Brant McCuen's contract for County Sanitarian position effective March 31, 2025. All supervisors voted aye. Motion carried. Received four applications for the permanent County Sanitarian position. Shipley and Akin will serve on the interviewing committee and will give a recommendation for the final hire.

Department heads reports: Sheriff – Received \$16,000 for the truck bid on Purple Wave. The Crown Vic has been transferred to the new owner. Conservation – Hunter Education class is this Friday and Saturday and there are a few seats left. There was some wind damage from last week's storm. Looking at some steps and bridges for repairs. The triathlon date has been set for August 23<sup>rd</sup>. Working on marketing for the 5k fun run/walk. Working with Secondary Roads on brooming some intersections on the route to get rock off the roadway. Lake Icaria is more than two feet lower than normal therefore, we are going to wait on putting in some docks. Water to the park will be turned on soon. Winter rates are in effect until May 1. Still waiting on ICAP for some wind/hail damage to cabin roofs. Secondary Roads hauled rock to some camping sites, and we appreciated their help. Treasurer –The new hire is up and going and doing great. This is a very busy time of year with tax payments coming in. IT – MS-ISAC & EI-ISAC services moved to CISA, but still losing educational webinars due to the cuts at the federal level. Auditor – Attended ISAC conference and learned the potential effects of the new proposed tax bill. Then attended an ICAP conference that was all geared towards AI.

Committee and Meeting Reports: Maynes – Crossroads, March 20, via Zoom; Standley – DECAT, March 21, Creston; Shipley – Main St. EV, March 19, Corning; Akin – ACEDC, March 20, Corning.

Akin moved, seconded by Standley to adjourn the meeting at 10:40 AM. All supervisors voted aye. Motion carried.
