Shipley moved, seconded by Akin to approve signing Memorandum of Understanding with Adair for Judicial Mental Health Advocate. All supervisors voted aye. Motion carried.

Department heads reports: IT – Working through Solutions contract. Auditor – Sat in on a webinar with Senator Dawson giving more details on the new tax reform bill that has been introduced. Dissecting the bill and drafting an email to send concerns about how it will impact Adams County. Conservation – Introduced Brett Silva as the new Park Ranger hire. He's fitting in quite well and looking forward to his contribution to the park. Working with Joe Newsome on a comprehensive plan for bridge repairs on the trail. Boat docks have been put in the water where they feel comfortable but need more water for the rest of the docks. Started turning on water at the park. Lake View bathrooms are open, and Timber Ridge bathrooms should be open this week. The fish grinders will be turned on later. Currently in spring start-up mode. Will be hiring seasonal help in the upcoming weeks.
