The Adams County Board of Supervisors met on Tuesday, November 25, 2025, at 9:00 AM with the following members present: Scott Akin, Leland Shipley, Chris Standley, Bobbi Maynes, and Tony Hardisty. Standley left the meeting at 10:05 AM. The meeting was called to order by Chairperson Hardisty at 9:00 AM. The Pledge of Allegiance was recited. Akin moved, seconded by Maynes to approve the agenda and the minutes of the November 18th meeting. All supervisors voted aye. Motion carried. There were no public comments.

Secondary Roads Update – Obtained Ford F550 truck quote. Nick attended hungry canyon meeting, and we were approved for reimbursement. Discussion was held regarding a Crossroads letter of support for grant application. They are requesting 25% in additional funding, which would be about \$2,658 from Adams County’s opioid funds. Akin moved, seconded by Standley to approve signing letter of support for Crossroads to accompany their FY26 RFP BHTHPTR26093 Opioid Settlement Funding application (Grant #638841). All supervisors voted aye. Motion carried.

Hardisty reached out to Quincy Township trustee Tony Mullen to discuss the open clerk position. Deputy Auditor Shires reminded the board that appointed clerks are now a county employee. Akin moved, seconded by Shipley to appoint Mike Travis as Quincy Township clerk. All supervisors voted aye. Motion carried.

Discussion was held regarding the generator at Edge Ag is already being serviced and does not need to be included in this maintenance agreement. Akin moved, seconded by Maynes to approve the Cummins Sales and Service Generator maintenance agreement for one generator in the amount of \$3,896.91 for three years. All supervisors voted aye. Motion carried.

Department heads reports: Treasurer – All is going well in the office. Auditor – Attended a Real Estate conference last week. Working on budget amendment. Starting to work on valuations and budgets.

Committee and Meeting Reports: Maynes – District 4 meeting, November 19, via Zoom, Crossroads, November 24, Creston; Standley – DECAT, November 21, Creston; Hardisty – SCI 911, November 19, Creston.
